

INTRODUCTION

REALISE-Forum focuses on specific support policies for electricity produced from renewable energy sources (RES-E). The project investigates the experience gained with national feed-in schemes (FIT) and tradable green certificates (TGC) as well as the feasibility of a potential coordinated approach in the EU after 2010. Major results are an actor-focused analysis of the interplay between liberalisation and RES-E markets, an appraisal of the consensus on national support schemes, the establishment of a RES-E stakeholders' platform and recommendations for policy. In addition to eight national consultations, the project also organised two international workshops aimed at wider exchange of views among experts and stakeholders on some key topics. The coordinator, the Environmental Policy Research Centre (FFU) of the Freie Universität Berlin, has the pleasure to invite you to attend the final conference.
